* *Costco v. Omega* and *Flores-Villar v. US* were aff'd 4-4. *Tolentino v. New York* was dismissed as improvidently granted. *Madison v. Oneida* was dismissed prior to oral arguments and is therefore not represented on this chart. The Court scheduled 79 cases for oral argument and, after two dismissals and two 4-4 decisions, the Court is now expected to release 75 signed opinions for the current Term.
