My name is Ali Hamza AL-bahlol. I am currently imprisoned, by the U.S. government, in Guantanamo Detention Center. I am supposedly serving an alleged "life imprisonment sentence" ruled by an alleged "Military Commission". The so called ruling was dated on Nov 3, 2008 and of a case # 09-001.

I was recently informed that there is an ongoing case, in the Court of Appeals, appealing/challenging the ruling of the Military Commission mentioned above. I have not filed such a case or any other case in any U.S. legal system. I have not authorized any attorney to file such a case or any other case in any U.S. legal system. Therefore, I request to withdraw the case filed to Appeal/challenge the Military Commission's ruling. Also, I request to withdraw all other cases under my name or filed on my behalf. Further, I request to revoke any authorization, given on my behalf, to any attorney.

I am an adult and I believe I do have an access to the U.S. Civilian legal system. Thus, there shall not be, in the future, any case filed on my behalf or under my name unless I visually approve such a filing.

Finally, I confirm that I am not coerced, neither mentally nor physically, with respect to writing this letter.
