**CostCo v. Omega* was aff'd 4-4. *Tolentino v. New York* was dismissed as improvidently granted. *Madison v. Oneida* was dismissed prior to oral arguments and is therefore not represented on this chart. The Court scheduled 79 cases for oral argument and, after two dismissals and one *per curiam* opinions (*CostCo*), the Court is expected to release 76 signed opinions for the current term.
